# Selected Votes in the New Hampshire House of Representatives

## House Bill 627 - RESTORING 17-YEAR-OLDS TO JUVENILE JUSTICE SYSTEM

*Sponsors: Representatives David Bickford (New Durham); Barbara Richardson (Richmond); Julie Brown (Rochester); Mary Gile (Concord); Sandra Keans (Rochester)*

Allowing juvenile courts to maintain jurisdiction over 17-year-olds makes sense for children, families, and public safety. Mixing young offenders with adults teaches the children to be better criminals, not productive adults. When young offenders are retained in the juvenile system, they are better monitored and less likely to re-offend. The House passed HB 627 by a vote of 258-107. It was also passed by the Senate, and signed into law by the Governor.

A vote for children was a YES to the committee recommendation of Ought to Pass with Amendment.

## House Bill 1331 - FAMILY SUPPORT AND ASSISTANCE

*Prime Sponsor: Representative Janeen Dalrymple (Salem)*

New Hampshire law on family public assistance sets two long-term goals: to enable families to achieve financial self-sufficiency and to raise children out of poverty. In enacting HB 1331, the legislature has made these goals harder to meet by focusing on federal participation rates instead of family outcomes, restricting job readiness and post-secondary training, and increasing financial penalties for non-compliance. The House passed the bill's conference committee version by a vote of 182-121. The Governor allowed the bill to become law without his signature, and issued an executive order to assure access to support services, and to establish an Advisory Council to monitor the bill's implementation.

A vote for children was a NO to adopt the Committee of Conference Report.

## House Bill 1580 - CHILD SUPPORT FORMULA

*Prime Sponsor: Representative David Bickford (New Durham)*

New Hampshire law requires that custody proceedings focus on the best interests of the child. By connecting parenting time and child support, HB 1580 created a financial incentive to seek increased parenting time, without incorporating successful methods used in other states. Based on the fiscal note, HB 1580 would have reduced child support for already vulnerable families, likely increased the number of children living in poverty and the public assistance needed to support them, and reduced the amount of general fund offset for the TANF program. The House voted in favor of these changes, 186-146. The bill was later defeated in the Senate.

A vote for children was a NO to the committee recommendation of Ought to Pass with Amendment.

## Senate Bill 131 - SCHOOL VOUCHERS

*Prime Sponsor: Senator Carl Johnson, District 2*

When the Senate approved school vouchers in SB 131, it supported legislation that would divert taxpayer dollars away from local schools. Under the title "21st Century Scholars," SB 131 would have given certain students vouchers for public or nonpublic schools, despite the proposal's uncertain constitutionality. Public education should be strengthened and renewed; this diversion of public funds would have undermined quality public schools. The House defeated SB 131, 172-136.

A vote for children was a YES to the committee recommendation of Inexpedient to Legislate.

## Senate Bill 306 - EARLY LEARNING

*Sponsors: Senators Iris Estabrook, District 21; Richard Green, District 6; Senator Bob Odell, District 8; Senator Joseph Foster, District 13; Senator John Gallus, District 1; Senator Margaret Hassan, District 23; Senator Andre Martel, District 18; Senator Martha Fuller Clark, District 24; Representatives James Pilliod (Belmont), Carolyn Gargas (Hollis), Mary Gile (Concord), Mary Jane Wallner (Concord)*

Quality early care and education programs support the well being of both children and working families in New Hampshire. SB 306 sought to establish a one-year early learning initiative, and to establish funds for enhanced childcare reimbursement. The initiative passed the House, 192-143, and although it was defeated by the Senate, its provisions were incorporated into HB 1626 and signed into law.

A vote for children was a YES to the committee recommendation of Ought to Pass with Amendment.

# Selected Votes in the New Hampshire Senate

## Constitutional Amendment Concurrent Resolution 43 - CONTENT AND FUNDING OF EDUCATION

Public education lays the foundation for a healthy democracy, a prepared workforce, and a flourishing economy. The state constitution defines public education as one of the interests essential to the preservation of a free government; this last-minute resolution sought to remove public education from these interests, and proposed that the content, extent, and funding of education be defined solely by the legislature. CACR 43 would have demoted public education from a protected right to simply another commodity. The Senate rejected the resolution, 14-10.

A vote for children was a NO to the committee amendment.

### House Bill 37 - 'MICHELLE'S LAW'

*Sponsors: Representatives William Infantine (Manchester), Benjamin Barody (Manchester), Raymond Hebert (Manchester), Keith Hirschman (Manchester), and Jeffrey Aboshar (Manchester)*

HB 37, better known as "Michelle's Law," was a grassroots-led bill which sought to protect seriously ill college students from losing their health insurance if serious illness prevents full-time attendance. The campaign to pass HB 37 was led by college student Michelle Morse and her family after she was diagnosed with cancer in 2005. Sadly, Michelle lost her struggle against cancer in November of 2005, but the children of NH won when the Senate passed "Michelle's Law" with unanimous support. HB 37 was also passed by the House, and was signed into law by the Governor.

A vote for children was a YES to the committee recommendation of Ought to Pass with Amendment.

### House Bill 76 - STATE AID TO CHARTER SCHOOLS

*Sponsors: Representatives John Hunt (Ringe), Claire Snyder (Somersworth), and Peter Sullivan (Manchester)*

Although the House soundly defeated SB 131, which proposed to establish a school voucher program, much of it was later added to HB 76 in the Senate. This included the diversion of \$250,000 in public funds to nonpublic schools, despite the fact that the state constitution forbids taxpayer dollars from going to religious schools. The Senate passed the amended bill by a vote of 15-8. The House again rejected the voucher program, although support for the bill's primary thrust, a guarantee that directs per-pupil aid to charter schools directly from the state instead of local districts, plus \$400,000 in charter school seed money, remained intact.

A vote for children was a NO to the committee recommendation Ought to Pass as Amended.

### House Bill 1331 - FAMILY SUPPORT AND ASSISTANCE

*Prime Sponsor: Representative Janeen Dalrymple*

New Hampshire law on family public assistance sets two long-term goals: to enable families to achieve financial self-sufficiency and to raise children out of poverty. In enacting HB 1331, the legislature has made these goals harder to meet by focusing on federal participation rates instead of family outcomes, restricting job readiness and post-secondary training, and increasing financial penalties for non-compliance. The House passed the bill's conference committee version by a vote of 182-121. The Governor allowed the bill to become law without his signature, and issued an executive order to assure access to support services, and to establish an Advisory Council to monitor the bill's implementation.

A vote for children was a NO to the committee recommendation of Ought to Pass with Amendment.

### House Bill 1580 - CHILD SUPPORT FORMULA

*Prime Sponsor: Representative David Bickford*

New Hampshire law requires that custody proceedings focus on the best interests of the child. By connecting parenting time and child support, HB 1580 created a financial incentive to seek increased parenting time, without incorporating successful methods used in other states. Based on the fiscal note, HB 1580 would have reduced child support for already vulnerable families, likely increased the number of children living in poverty and the public assistance needed to support them, and reduced the amount of general fund offset for the TANF program. The House voted in favor of these changes, 186-146. The bill was later defeated in the Senate.

A vote for children was a YES to the committee recommendation of Inexpedient to Legislate.

# Methodology

The *2006 Legislative Report Card* evaluates roll call votes on selected bills affecting children. The bills selected address issues ranging from education, to child health, to family strength. We note that several important bills could not be included in this report because they were decided by voice vote and no record exists of how individual legislators voted.

A description of each bill is included on page 4 (House) and page 9 (Senate). Each description addresses the stated purpose of the bill, its likely impact on children, the vote count and the current status. It is important to read these descriptions to understand why a "Yes" or "No" vote constituted a vote for children. For example, if the motion being voted upon was to find a child-friendly bill "Inexpedient to Legislate" (meaning a committee has recommended that it not pass), then a "No" vote was a vote for children.

For each bill, legislators who cast a vote receive either a "★", to represent a vote for children, or a "-", to represent a vote against children. Legislators who did not vote received an "A" for absent or abstained, a "C" for a declared conflict of interest, or, in the cases of the House Speaker or Senate President (or the ranking members who occasionally stand in for them), a "P" for presiding. An "NA" indicates that the legislator was not yet or no longer a member at the time of the vote. This report card includes all legislators from every NH district with representation at the time of the vote.

The score for each year represents the legislator's percentage of favorable votes for children. **The higher the score, the more often the legislator voted in favor of children.** The percentage is based on the number of votes cast: missed votes do not count against a legislator's final score. A prior year's score of "NA" means that person was not yet elected to the Legislature.

The Children's Alliance of New Hampshire believes that **children need every vote they can get and that New Hampshire children need their legislators to be there for them.** This means being present for all key votes affecting children. To reflect the importance of voting on all key bills affecting children, this report card includes an honor roll (marked by a "★" after the "100" score) that recognizes legislators who were present for all the votes listed in this report and who voted for children each time. The one exception to this honor roll formula is for legislators who didn't vote on a bill because they declared a conflict of interest.

The votes here were taken directly from the state's official Web site ([www.state.nh.us](http://www.state.nh.us)). While we believe our account to be accurate, it is only as accurate as the vote tallies recorded by the House and Senate and posted on the state Web site.

We encourage you to communicate frequently with your legislators about their votes and to share your expectations with them. Please let them know how vital it is that they attend key votes and vote in favor of children. It is also important to urge legislators to request recorded votes on our issues - when doing so would not endanger child-friendly legislation or promote negative bills. The lack of recorded votes makes it difficult to hold lawmakers accountable for their actions.

One final note. **The Children's Alliance never endorses nor opposes political candidates, and this report cannot be interpreted as an endorsement or a rejection of any candidate.** The information provided does not represent a full accounting of any legislator's work or record on issues related to children, such as voice votes or committee work done out of the public eye.



# Review of 2006 children's legislation

Arrows indicate positive result (up arrow), negative result (down arrow), and mixed results (two-way arrow) on legislation affecting children. An open circle indicates an unresolved bill, which was either tabled or sent to interim study.

## Economic Security

- ▲ HB 1461, establishing a task force to study the sufficiency of TANF benefits was signed into law. Under this law, the TANF Study Committee must include a representative appointed by the New Hampshire Child Advocacy Network.
- ▼ HB 1528, establishing a committee to study the adequacy of state consumer protection laws related to predatory lending, was defeated in the House.
- ▼ HB 1708, expanding TANF eligibility for two parent families, was defeated in the House.
- ▲ HB 1746, which sought to restrict TANF eligibility by capping benefits to recipients who had an additional child while receiving benefits, by removing job readiness and training activities from allowable work activities, and by reducing the eligibility period, was defeated in the House.
- SB 331, establishing a limit of 100% on certain small loan interest rates in response to predatory lending practices, was tabled.

## Child Safety and Well Being

- ▲▼ HB 529, initially requiring the court to provide detailed reasons if "comparable parenting" (not defined) was not found to be in the best interests of the children, was amended to require support for comparable parental rights and responsibilities whenever appropriate and was signed into law.
- ▲▼ HB 1583, initially requiring court ordered custody modification every three years and to give substantial weight to mature minor children when determining residence, was amended in the Senate to remove the three-year requirement, and signed into law.
- ▲ HB 1585, initially proposing an expedited hearing process (10 days) for non-compliance with approved parenting plan, custody or visitation order was amended in the Senate to establish a hearing time of 30 days for contempt or enforcement of approved parenting plan, and signed into law.
- ▲ HB 1692, increasing penalties for sexual predators, was signed into law.
- HB 1127, clarifying the responsibility of all adults, including religious leaders, to report suspected child abuse and neglect, was referred to interim study.

## Education

- ▼ HB 1170, requiring State Education aid to be used solely for public education was defeated in House.
- ▲ HB 1241, originally proposed to ensure every child in the state had access to public kindergarten, was amended in the House to extend kindergarten construction aid and signed into law.
- ▲ HB 1249, appropriating state funding for the existing school breakfast program at three cents per meal reimbursement to schools, was signed into law.
- ▲ HB 1707, establishing a school choice certificate program, was defeated in the House.
- ▼ SB 290, establishing a wellness program in public schools, was defeated in the Senate.

## Health and Wellness

- ▼ HB 1177 sought to ban smoking in bars and restaurants, and would have protected NH children from second-hand smoke, was defeated in the Senate.
- ▲ HB 1581, establishing a vertical design driver's license for drivers under age 21, was signed into law.
- SB 338, requiring private insurers to cover services by licensed occupational therapists, physical therapists, speech therapists, and clinical social workers to children from birth to 36 months was tabled.
